## **The Third Annual Conference Of ISHWM**

The third annual conference of the Indian Society of Hospital Waste Management was hosted by Armed Forces Medical College, Pune with the theme “ Biomedical Waste Management - Introspection and Implementation”, on 17-18 May 2003.

Air Marshal SK Dham, PVSM, AVSM, VSM, PHS, President, ISHWM delivered the keynote address. He expressed his satisfaction at the fact that the number of members had grown and that the trend showed acceptance of the society as a professional body. He stressed the need for the society members meeting more often amongst themselves and also interacting with professionals outside. He complimented the organizing committee and especially Col Zile Singh, the Organising Secretary of the conference for the excellent arrangements. He also commended Dr. D. Gopinath, and his team for bringing out the second issue of the journal.

Surgeon Rear Admiral P Sivadas, Secretary ISHWM presented Annual Report to the society. He highlighted the various achievements of the Society and informed the house that 35 new members had joined the society since the second annual conference. He appealed to the members to view the website and offer comments/ suggestions as well as submit material for the website. He informed the house that IT exemption case, which was being pursued with IT department, has come through and now contributors to the society will be eligible for IT benefit. The secretary informed the progress on various points discussed in AGM of 12 Apr 2002. He concluded by informing the house that two proposals on newer techniques on HWM had been received from Bangladesh and Australia, which were being studied and would be appropriately responded to by the society.

Wg Cdr Ashutosh Sharma, Treasurer ISHWM informed of the auditors' suggestion to transfer surplus funds available in saving bank to term deposits. He informed that the excess of income over expenditure for the year 2002-2003 was Rs 28,970.53. The balance sheet was approved and statement of account was unanimously passed.
